# TRAUMA INFORMED CARE AND

#### **MEDICATION ASSISTED TRAINING**

These workshops are appropriate for practicing counselors, social workers, psychologists, and other behavioral
health professionals as well as master and doctoral level students about to enter the field.

1. The Trauma Informed Care (TIC) Workshop is 6 hours and will include information on the sources of trauma, impact of culture, service systems as intervention venues, a historical retrospective on the treatment of trauma and trending treatments today, the SAMSHA concept of trauma, key assumptions and principles of a trauma informed approach, guidance in implementing a trauma-informed approach, analyzing case studies, and discussing trauma in the context of community. Through CSU partnership with BTST Cares, attendees can receive 6 CEUs from the Maryland Board of Professional Counselors and Therapists or the Maryland Board of Social Work.

#### Upon completion of the TIC course, participants will be able to

- 1. Define trauma and the impact of trauma on culture, health and mental health and vice versa
- **2.** Understand trauma and its treatment from a historical perspective and the impact on current treatment and practice
- **3.** Articulate the role of service systems as intervention venues
- 4. Identify the implementation domains and explain how they can be integrated into practice
- **5.** List principles of a trauma informed approach
- **6.** Articulate the need of tailoring trauma care within community context

2. The Medication Assisted Training (MAT) Workshop is 4 hours and will include information on the scope of the opioid addiction problem, how to assess it, the conceptual framework based on the biology of addiction, treatment medications, clinical treatments and limitations to current practice, treatment implementation and models of care, special populations, treatment delivery and system enhancements and medications for alcohol, tobacco, and other substances.

#### Upon completion of the MAT course, participants will be able to

- 1. Articulate incidences and prevalence of opioid drug use.
- 2. List and apply assessment processes and procedures in evaluating opioid drug use severity.
- 3. Understand the neurobiology of opioid dependence and the implications for treatment.
- 4. Understand the role of medication in opioid dependence treatment.
- 5. Analyze and apply evidence-based practice education, counseling, and psychotherapy approaches to opioid dependence treatment.
- 6. Articulate the limitations of current treatment approaches.
- 7. Articulate interprofessional roles and approaches to interprofessional collaboration in a system of care.
- 8. Analyze treatment approaches for special populations including pregnant women, persons in the criminal justice system, persons with co-occurring disorders, and in pain management.
- 9. List treatment approaches along a continuum of care and in challenging situations.
- 10. Explain process of medication management in the treatment of alcohol, tobacco, and other substances.
